

## **“AVA Conference WA 2021 Event Competition” PROMOTION TERMS AND CONDITIONS**

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is open to Australian residents who attended the Australian Veterinary Association Conference in Perth (Event dates: October 15 2021 to Sunday 17 October 2021).
